Thank you very much for detailed explanations, which will be helpful for our discussion in Modra. At the same time we still have doubts regarding readiness of prepared Carpathian Red List of Forest Habitats and Red list of Vascular Plants of the Carpathian for the adoption by COP 5.

According to the evaluation of the experts of the National Academy of Sciences of Ukraine these drafts of Carpathian Red List of Forest Habitats and Red List of Vascular Plants of the Carpathian are required significant improvement since there are inaccurate references, the lists themselves are incomplete, there are species that have never met in the Carpathians, because they are endemic to the Crimean Mountains or are distributed exclusively in the steppe and forest-steppe natural zones of Ukraine.

Following the recommendations of the last Carpathian Convention Implementation Committee calling for finalization of the Carpathian Red List of Forest Habitats and the Red List of Vascular Plants of the Carpathians, please let me share with you the required documents.

Attached is the table with threatened forest habitat types with description of relevant habitats. Due to different classification systems used in the Carpathian countries, in the process of assessment of habitats used was the European Nature Information System (EUNIS) habitat classification, as agreed at the beginning of the work on this activity within the BioREGIO project. The table was developed in cooperation with Mr. Luboš Halada, Science for the Carpathians.
